ORDER

WHEREAS, Ram Baran Ray B.Ed. College, Plot No.27, Street Number-Main Road, Vill-Shyampur Bairo (Main Bairo), P.O.-Hansi Kewal, Tehsil/Taluka-Bhagwanpur, Town/City-Bhagwanpur, District-Vaishali, Bihar-844131 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.13256 dated 13.08.2012 from the academic session 2012-2013, followed by revised recognition order vide No.32072 dated 25.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. **AND WHEREAS,** the ERC in its 278th meeting held on 16th-18th January, 2020 decided that recognition granted to B.Ed. course be withdrawn from the academic session 2020-2021. Accordingly, withdrawal order issued vide No.62217 dated 01st February, 2020.
- 3. **AND WHEREAS,** institution filed a petition C.W.J.C. 3417/2020 in the Hon'ble High Court of Judicature at Patna and the Hon'ble Court passed orders dated 19.02.2020, 13.10.2020 and 16.10.2020. The operative part of the order dated 16.10.2020 is as under:-
 - "...It is evident from the aforesaid decision that there is no consideration of the materials and it is for this reason that learned counsel for the respondents is not able to controvert the submissions of learned Senior Counsel for the petitioner. The impugned order, therefore, suffers from non-consideration of the materials available on the record, it is vague and totally unreasoned, therefore, the same is set aside in so far as it relates to the petitioner.

The respondents are directed to take a fresh decision within a period of eight weeks from today after considering all the materials on the record and also the relevance of the materials which respondents are looking for in the matter of recognition of B.Ed. course which has already been granted earlier and has been sought to be withdrawn by the impugned order for the aforesaid reasons. It will also be open to the respondents to seek any clarification from the petitioner if so required in order to take a decision.

This writ application stands allowed to the extent indicated hereinabove."

4. **AND WHEREAS**, the institution submitted representations dt. 09.09.2020 along with certain documents received on 16.09.2020 in reply of comments sought by ERC vide letter dated 21.02.2019 in connection with complaint against the institution made by Shri Ram Chandra Rai, S/o- Sh. Ram Baran Rai, Vaishali, Bihat.

5. **AND WHEREAS,** the ERC in its 301st (Emergent) Meeting held on 21.01.2022 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the orders dated 19.02.2020, 13.10.2020, 16.10.2020 passed by the Hon'ble High Court of Judicature at Patna in C.W.J.C. 3417/2020 and the Committee decided as under:-

Restoration of recognition order to the institution viz. Ram Baran Ray B.Ed. College, Plot No. 27, Street Number-Main Road, Vill- ShyampurBairo (Main Bairo), Po- HansiKewal, Tehsil/Taluka- Bhagwanpur, Town/City- Bhagwanpur, Dist.- Vaishali, Bihar-844131 for B.Ed. course with annual intake of 100 students (02 units) be issued up to the end of academic session 2021-2022.

6. NOW THEREFORE, withdrawal order dated 01st February, 2020 issued to the institution viz. Ram Baran Ray B.Ed. College, Plot No.27, Street Number-Main Road, Vill-Shyampur Bairo (Main Bairo), P.O.-Hansi Kewal, Tehsil/Taluka-Bhagwanpur, Town/City-Bhagwanpur, District-Vaishali, Bihar-844131 for B.Ed. course is hereby restored with annual intake of 100 students (02 units) up to the end of academic session 2021-2022.

Further, on further verification and scrutiny of documents in light of NCTE Norms and Regulations, that the institution had produced before the Hon'ble High Court of Judicature at Patna related to show cause notice dated 28.11.2018 and withdrawal order dated 01.02.2020, as mentioned in its order dated 16.10.2020, the Committee observed that the institution is having certain deficiencies, as mentioned in the minutes of 301st Emergent ERC meeting, to be complied by the institution. The show cause notice u/s 17 of NCTE Act, 1993 in this regard is being issued to the institution separately.

7. The terms and conditions of the revised recognition order No.32072 dated 25.05.20 issued to the institution shall remain unchanged.
